DOI - The Department of Interior (DOI) Extractive Industries Transparency Initiative (USEITI) Multi-Stakeholder Group (MSG) Advisory Committee will hold meetings on June 27-28 and November 16-17. DOE - The Department of Energy (DOE) Methane Hydrate Advisory Committee will hold a meeting on June 8 to provide advice on potential applications of methane hydrate and assist in developing recommendations and priorities for DOE's Methane Hydrate Research and Development Program. NSF - The National Science Foundation (NSF) Committee on Equal Opportunities in Science and Engineering will hold a meeting on June 8-9 to study data, programs, policies, and other information pertinent to the NSF broadening participation in science and engineering. NRC - The Nuclear Regulatory Commission (NRC) has issued the final "Supplement to the U.S. Department of Energy's Environmental Impact Statement for a Geologic Repository for the Disposal of Spent Nuclear Fuel and High-Level Radioactive Waste at Yucca Mountain, Nye County, Nevada", and is limited to the potential environmental impacts from the proposed repository on groundwater and from surface discharges of groundwater. BOEM - The Bureau of Ocean Energy Management (BOEM) is publishing a list of restricted joint bidders for offshore oil and gas leases. Each entity within one of the following groups is restricted from bidding with any entity in any of the other following groups at Outer Continental Shelf (OCS) oil and gas lease sales to be held during the bidding period of May 1 to October 31. NASA - The Planetary Protection Subcommittee of the NASA Advisory Council will hold a meeting on June 1-2 to provide updates on Planetary Protection in the Mars Exploration Program and Planetary Protection Technology Investments. [Wednesday, May 18, 2016 (Volume 81, Number 96)]

EPA - The Environmental Protection Agency (EPA) is announcing the availability of the document titled, "Stormwater Management in Response to Climate Change Impacts: Lessons from the Chesapeake Bay and Great Lakes Regions". [Thursday, May 19, 2016 (Volume 81, Number 97)]

NRC - The Nuclear Regulatory Commission (NRC) is denying two petitions for rulemaking, submitted on behalf of 34 environmental organizations. The petitioners request that the NRC revise certain regulations that concern the environmental impacts of spent fuel storage and disposal for nuclear power plant license applications.
