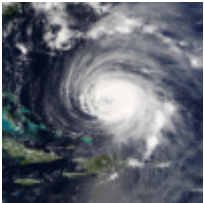
On October 8, 2015 President Obama signed into law the STEM Education Act of 2015 (H.R. 1020).

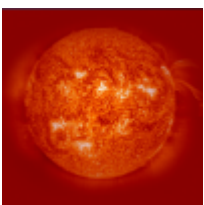

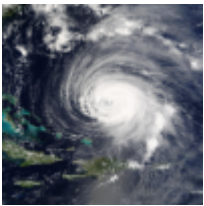

In order to keep up with increasing ship traffic in the Arctic Ocean, President Obama has announced his plan to accelerate the

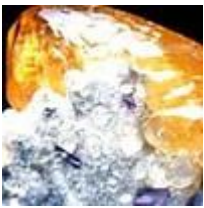
acquisition of a new heavy icebreaker for the United States.

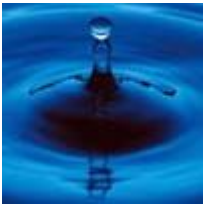


### **House Committee hears testimony on Administration's proposed "social cost of carbon" rule**

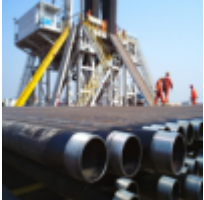

Legislators on both sides of the aisle have proposed 114 bills spanning energy efficiency, infrastructure, supply, and accountability and reform to be considered as a part of Murkowski's larger energy legislation package, which she hopes to have completed before the end of the summer.
