# Senate Committee assesses drought conditions in 11 Western States

Date: Tuesday, June 2, 2015

The Senate Energy and Natural Resources Committee held a hearing on June 2 to assess drought conditions and water challenges in the western United States.



#### NOAA reports potential coverage risk for U.S. weather data

Date: Monday, June 1, 2015

According to a report from the Department of Commerce's Inspector General, the National Oceanic and Atmospheric Administration's (NOAA) weather satellites could be vulnerable for the next 29 months due to construction delays.



# Oklahoma passes law prohibiting outright bans on hydraulic fracturing

Date: Monday, June 1, 2015

On May 29, Oklahoma Governor Mary Fallin signed a bill into law restricting municipalities from regulating oil and gas activities in their jurisdictions.



#### Maryland imposes 2-year moratorium on hydraulic fracturing

Date: Saturday, May 30, 2015

With the passage of a new bill, the state of Maryland will not allow hydraulic fracturing until October 1, 2017.



#### NOAA opens \$24.5 million National Water Center in Alabama

Date: Tuesday, May 26, 2015

The National Oceanic and Atmospheric Administration (NOAA) opened its new National Water Center on The University of Alabama campus on May 26.



# Senate Appropriations Committee approves FY 2016 Energy and Water bill

Date: Thursday, May 21, 2015

The Senate Appropriations Committee met on May 21 to mark up the fiscal year (FY) 2016 energy and water development funding bill. The bill that passed the committee totals \$35.4 billion, \$1.2 billion above the FY 2015 enacted level and \$668 million below the President's request.



# Asteroid mining bill passes the House

Date: Thursday, May 21, 2015

The House passed the Spurring Private Aerospace Competitiveness and Entrepreneurship Act (SPACE) of 2015 on May 21, which is designed to facilitate exploration and exploitation of space resources by American businesses.



# Senate Appropriations Committee finalizes Interior, Environment spending levels for FY 2016

Date: Thursday, May 21, 2015

On May 21, the Senate Appropriations Committee allocated \$30.01 billion to the Subcommittee on Interior, Environment and Related Agencies to cover funding for the Department of the Interior (DOI), U.S. Geological Survey (USGS), Environmental Protection Agency (EPA), U.S. Forest Service, and other agencies for fiscal year (FY) 2016.



# House Appropriations Committee passes CJS FY 2016 spending bill with cuts to NOAA and NASA programs

Date: Wednesday, May 20, 2015

The House Appropriations Committee passed the Commerce, Justice, Science, and Related Agencies (CJS) spending bill for fiscal year (FY) 2016 by voice vote on May 20.



#### House spending bill cuts NSF funding to Geoscience Directorate

Date: Wednesday, May 20, 2015

On May 20, the House Appropriations Committee passed the fiscal year (FY) 2016 Commerce, Justice, Science, and Related Agencies spending bill with language setting directorate-level funding for the National Science Foundation (NSF), a change from current agency-level funding.



# Bicameral push would give DOI discretion over pipeline permits through national parks

Date: Wednesday, May 20, 2015

Members of the House and Senate have introduced bills that would give the Department of the Interior (DOI) authority over natural gas pipeline permitting on federal lands in lieu of congressional oversight.



#### Senate bill would increase DOE basic energy research funding

Date: Wednesday, May 20, 2015

A Senate bill (S. 1398) introduced on May 20 would provide an alternative to the energy research funding levels proposed in the America COMPETES Reauthorization Act of 2015, which passed the House on May 19.



# House passes Weather and Forecasting Innovation Act

Date: Wednesday, May 20, 2015

On May 20, the House passed the Weather Research and Forecasting Innovation Act (H.R.1561) which would fund the National Oceanic and Atmospheric Administration (NOAA) and Office of Oceanic and Atmospheric Research (OAR) research on storm forecasting and early warning systems.



#### Bureau of Reclamation sends \$50 million to water-starved Western states for water conservation

Date: Wednesday, May 20, 2015

The Department of the Interior announced on May 20 that \$50 million from the Bureau of Reclamation's WaterSMART grants will be sent to 12 drought-stricken states for water reclamation and reuse facilities, recycling and desalination programs, and water and energy infrastructure and efficiency initiatives.



# Texas law restricts local laws regarding oil and gas

Date: Tuesday, May 19, 2015

Texas governor Greg Abbott signed TX HB 40 into law on May 19 in an effort to create continuity in oil and gas restrictions

across the state.



# Murkowski, Heitkamp introduce Senate bill to allow crude oil exports

Date: Tuesday, May 19, 2015

One week after introducing the Energy Supply and Distribution Act of 2015 (S. 1312), which would lift the US ban on exporting its crude oil to other nations, Senators Heidi Heitkamp (D-ND) and Lisa Murkowski (R-AK) have introduced a second, more focused bill on the issue.



#### Federal science bill passes House amid funding debate

Date: Tuesday, May 19, 2015

On May 19, the House voted to approve the America COMPETES Reauthorization Act of 2015 (H.R. 1806).



#### Murkowski bill to overhaul minerals and mining regulations

On May 12, the Senate Energy and Natural Resources Committee (ENR) held a hearing to consider the American Mineral Security Act of 2015 to increase support for minerals science, information, and forecasting within the U. S. Geological Survey (USGS) Mineral Resources Program.



#### White House conditionally approves Arctic Drilling

The Bureau of Ocean Energy Management issued a statement on May 11 granting Royal Dutch Shell PLC conditional drilling

rights in the Chukchi Sea off Alaska's northwest coast.



#### GAO releases report on oil and gas monitoring and venting

Date: Wednesday, May 6, 2015

The Government Accountability Office (GAO) released a report on the Department of the Interior's (DOI) regulations regarding royalty payments and measurement standards for onshore oil and gas production.



# House approves FY 2016 Energy and Water Development Appropriations Bill

Date: Friday, May 1, 2015

On May 1, the House passed a \$34.5 billion Energy and Water spending bill by a vote of 240-177, largely along party lines.


The House Science, Space, and Technology Committee held a markup of the NASA Authorization Act for 2016 and 2017 (H.R.
