Department of Energy (DOE)

Meeting of Environmental Management Board

March 7, 2019 – DOE announced a meeting of the Environmental Management Board on April 23, 2019. The purpose of the meeting is to discuss waste disposition and regulatory affairs updates, budget and planning updates, and field operations. [[84 FR 8323](#)]

Meeting of National Coal Council

March 19, 2019 – DOE announced a meeting of the National Coal Council on April 11, 2019. The purpose of this council is to advise the energy secretary on energy matters relevant to the coal industry. [[84 FR 10053](#)]

Board of Scientific Counselors (BOSC) Homeland Security Subcommittee Meeting

Federal Emergency Management Agency (FEMA)

National Advisory Council (NAC) Applications Request

March 5, 2019 – FEMA is requesting applications for appointment to the National Advisory Council. Twelve positions are currently vacant: nine discipline-specific positions on the NAC and three positions for administrator selections. Applications will be accepted until March 15, 2019. Notice on the Final Flood Hazard Determinations

March 15, 2019 – FEMA issued a notice that its flood hazard determinations have been made final. Flood Insurance Rate Maps and the Flood Insurance Study reports will be available to the community on June 7, 2019. [[84 FR 9542](#)]

Final Rule on Evaluating a Governor's Request for Individual Disaster Aid

March 21, 2019 – FEMA issued a final rule on the factors considered when evaluating a governor's request for individual assistance for a major disaster. This rule falls in compliance with the Sandy Recovery Improvement Act of 2013, which requires FEMA to work with state, local, and tribal emergency management agencies to coordinate individual disaster assistance efforts. Federal Energy Regulatory Commission (FERC)

Security Investments for Energy Infrastructure Technical Conference Notice

March 7, 2019 – On March 28, 2019, FERC and DOE will cohost a Security Investments for Energy Infrastructure Technical Conference. This conference will be held to discuss cyber and physical security threats to energy infrastructure and how they can be circumvented. [[84 FR 8325](#)]

Fee Schedule for NOAA Environmental Data Access

March 27, 2019 – NOAA issued a rule to correct several mistakes that were included in a document previously published by the National Environmental Satellite, Data and Information Service (NESDIS) in the Federal Register on February 11, 2019 that established a new fee schedule for special access to NOAA data. National Science Foundation (NSF)

Notice of Advisory Committee for Polar Programs Meeting
