NSF- The National Science Foundation (NSF) published a notice of a permit application to conduct activities regulated under the Antarctic Conservation Act of 1978. Comments with respect to this permit application may be submitted by November 6, 2014. [Tuesday, October 7 (Volume 79, Number 194)]

EPA- The Environmental Protection Agency (EPA) held a public teleconference of the National Advisory Council for Environmental Policy and Technology (NACEPT). NACEPT provides the EPA with advice on environmental policy, technology, and management. The goal of the meeting was to develop sustainability strategies supporting the principles and practices outlined in the FY2014-2018 EPA Strategic Plan. EPA- The Environmental Protection Agency (EPA) and the U.S. Army Corps of Engineers (USACE) are extending the comment period for the proposed rule "Definition of 'Waters of the United States' Under the Clean Water Act" published on April 21, 2014. Comments must now be received on or before November 14, 2014. [Tuesday, October 14 2014 (Volume 79, Number 199)] NASA- The National Air and Space Administration (NASA) announced a meeting of the Planetary Science Subcommittee of the NASA Advisory Council (NAC). The goal of the meeting is to seek scientific and technical information relevant to program planning. The meeting will be held telephonically on November 21, 2014 from 12:00 to 3:00 pm. DOE - The Department of Energy (DOE) announced an open meeting of the Commission to Review the Effectiveness of the National Energy Laboratories. EPA- The Environmental Protection Agency has extended the comment period for the proposed rule titled "Carbon Pollution Emission Guidelines for Existing Stationary Sources: Electric Utility Generating Units" by 45 days. The original proposed rule included an incorrect digit in the docket number for the proposed rule; this proposed rule corrects that error. The correction is effective October 27, 2014.
