EPA - The Environmental Protection Agency's (EPA) Board of Scientific Counselors Air, Climate, and Energy subcommittee will hold a conference call from 3 to 5pm EDT on July 20. The call is open to the public. [Volume 80, Issue 126 (July 1, 2015)]

DOI - The Federal Energy Regulatory Commission (FERC) requested comments on its proposed five-year review of the index level used to determine annual changes to oil pipeline rate ceilings. Initial comments on this proposed index are due August 24, 2015. [Volume 80, Issue 130 (July 8, 2015)]
