Dear Senator Hatch,

The undersigned organizations are writing to thank for your leadership in championing legislation to establish clear standards for federal agencies in their utilization and dissemination of geospatial data. We strongly support S. 2128 and urge you to seek passage of this important bill.

The rapidly-growing geospatial technologies and analysis industries are currently estimated to produce over \$100 billion in revenue annually and will foster job growth of between 16-35 percent. All federal agencies generate, use, and share geospatial data, and the important provisions contained in the revised legislation would strengthen U.S. geographic science, research capacity, and competitiveness. This bill would harness the productivity, talent, scientific and technical skills, and creativity and innovation that characterize the nation's GIS and mapping companies and workforce.
